

# Political neutrality (Tenet 7)

For candidates running for public office, don't

- Sign petitions
- Endorse
- Donate to the campaign
- Donate to entity that supports
- Be one!
  - Start an exploratory committee?

#### New guideline

#### Personal Advocacy of Issues

Members share with their fellow citizens the right and responsibility to voice their opinion on public issues. Members may advocate for issues of personal interest only when doing so does not conflict with the performance of their official duties.





#### City funded housing authority

- You serve as Executive Director appointed by the city
- Housing authority offers a loan program
  - You meet the lending criteria
  - All city employees are eligible

Outline the steps you should take in order to make applying ethical?

### Ask yourself...

- Am I taking some official action, directing an employee, or using a city resource to do anything that involves my spouse, child, parent, friend, or sibling?
- Do I have a personal connection to a work issue?
- Will I gain from an official decision?

# Priceline CEO loses job over personal relationship with employee



### ICMA City Manager

Is living with his assistant

- Got permission to date
- Relationship doesn't violate state law (no city policy on this)
- Pay increases were approved by city council
- No evidence that staff object

Is this an ethics violation?

#### New proposed Tenet 3

"Demonstrate by word and action the highest standards of ethical conduct and integrity in all public, professional, and personal relationships in order that the member may merit the trust and respect of the elected and appointed officials, employees, and the public."



#### Tenet 4

"Recognize that the chief function of local government at all times is to serve the best interests of all of the people."



#### The Tenure "Rule"

- Professional tenure is 2 years
  - Short tenures should be the exception
  - Do your homework
  - Special exceptions, i.e. totally unusual and unpredictable
  - Applies to all members working in local government

#### Censured for...

- Dui...interfering with the process
- Took a position with a school district but didn't show; accepted a preferred city administrator position
- Someday, just in case
  - Negotiated an employment agreement while the position was still occupied




#### Censured for...

- Manager reimbursed for \$366k supplies, personal items, equipment, travel and meals that appeared unrelated to duties
- Manager directed staff to provide her with benefits that were in violation of county policy; <u>lied to her board</u>

#### Censured for...

- Said yes and bailed after signing employment agreement
- Verrrry short tenure (3 months)
- Smell test violations
  - Too close for comfort with a subordinate employee
  - Made broad assertions not backed with facts

# Ask before you act

- Sound legal advice is a starting not ending point
- Coach, mentor, trainer, BFF
- ICMA
  - Confidential advice
  - Talking about an ethics mistake doesn't trigger a review
  - In an ethics hole? Strategy to extricate you!
